§1 Applicability to companies and definitions of terms

§2 Conclusion of a contract, storage of the contract text

- (2) In the case of the conclusion of the contract, the contract comes with T. E. Webshops, exhibishop.com, Zandven 2B, 5508 RN VELDHOVEN The Netherlands. §3 prices, shipping costs, payment, due date

(1) The indicated prices do not include the statutory sales tax and other price components. In addition there are any shipping costs.

(2) The customer has the option of:

(3) Payment on account is applicable to a surcharge minimum of € 50,00 or 8% of the order value.

(4) If the customer has chosen to pay in advance, he undertakes to pay the purchase price immediately after conclusion of the contract within 8 days of the contract. As far as we deliver by cash on delivery, the due date of the purchase price claim occurs with receipt of the goods.

§4 delivery

(1) Provided that we have not stated this clearly in the product description, all items offered by us are ready to ship.

(2) If the customer has chosen payment in advance, we will not ship the goods before payment.

§5 Retention of title

We reserve the ownership of the goods until full payment of the purchase price is fulfilled.

§6 Contractual regulation regarding the return costs upon revocation
