SECTION3 HAZARDS IDENTIFICATION

Hazards Identification :

This substance is considered to be non-hazardous for transport.

Emergency Overview:

Irritating to eyes, respiratory systems and skin. May cause sensitization by skin contact.

SECTION4 FIRST-AID MEASURES
