

STANDING AUTHORITY TO ACT AS CUSTOMS REPRESENTATIVE

The entity named at A above hereby indemnifies the agent named at B above in respect of all and every liability in respect of Customs declarations completed by B on behalf of A, and undertakes to reimburse B in respect of any expenses incurred by way of duties, taxes, levies and any other charges whatsoever for which B may become liable as a result of presenting a Customs declaration on behalf of the entity named at A above.

The indemnities above shall be subject to any liabilities, damages and losses suffered or incurred by B being legally recoverable, foreseeable and to any costs and expenses being reasonable and nothing shall restrict or limit B's general obligation to mitigate any loss it may suffer or incur as a result of an event that may give rise to a claim under the indemnities provided by A.
