**SECTION 4: FIRST AID MEASURES**

**4.1 Description of first aid measures:**

The symptoms resulting from intoxication can appear after exposure, therefore, in case of doubt, seek medical attention for direct exposure to the chemical product or persistent discomfort, showing the SDS of this product.

**By inhalation:**

Remove the person affected from the area of exposure, provide with fresh air and keep at rest. In all cases, after cleaning, a doctor should be consulted as quickly as possible with the SDS of the product.

##### **By ingestion/aspiration:**

In the case of loss of consciousness do not administer anything orally unless supervised by a doctor. Rinse out the mouth and throat, as they may have been affected during ingestion. #### SECTION 5: FIREFIGHTING MEASURES

##### **5.1 Extinguishing media:**

###### **Suitable extinguishing media:**

Product is non-flammable under normal conditions of storage, manipulation and use, but the product contains flammable substances. In the case of inflammation as a result of improper manipulation, storage or use preferably use polyvalent powder extinguishers (ABC powder), in accordance with the Regulation on fire protection systems.

As a result of combustion or thermal decomposition reactive sub-products are created that can become highly toxic and, consequently, can present a serious health risk.

#### SECTION 6: ACCIDENTAL RELEASE MEASURES

##### **6.1 Personal precautions, protective equipment and emergency procedures:**

Isolate leaks provided that there is no additional risk for the people performing this task. Evacuate the area and keep out those without protection. Personal protection equipment must be used against potential contact with the spilt product (See section 8). Above all prevent the formation of any vapour-air flammable mixtures, through either ventilation or the use of an inert medium. Destroy any source of ignition. Eliminate electrostatic charges by interconnecting all the conductive surfaces on which static electricity could form, and also ensuring that all surfaces are connected to the ground.

##### **6.2 Environmental precautions:**

Avoid spillage into the aquatic environment as it contains substances potentially dangerous for this. Contain the product absorbed in hermetically sealed containers. In the case of serious spillage into the aquatic environment notify the relevant authority.

##### **6.3 Methods and material for containment and cleaning up:**

## SECTION 7: HANDLING AND STORAGE

### 7.1 Precautions for safe handling:

#### A.- Precautions for safe manipulation

Comply with the current legislation concerning the prevention of industrial risks. Keep containers hermetically sealed. Control spills and residues, destroying them with safe methods (section 6). Avoid leakages from the container. Maintain order and cleanliness where dangerous products are used.
