STORAGE REQUIREMENTS

During transport, keep the energy absorber in its packaging, well away from any cutting surface. Clean it with water, wipe it with a rag and hang it up in a well-ventilated location, to let it dry naturally and away from a naked flame or heat source; follow the same procedure for components that have become damp during use. The energy absorber should be stored in its packaging in a warm, dry, ventilated place, protected from sunlight, heat and chemicals.
